Quick Reference Sheet

About the SWA

The Sacramento Regional Solid Waste Authority (SWA) is a joint powers authority of the City of Citrus Heights, the City of Sacramento and the unincorporated areas of Sacramento County. The SWA Board members are elected officials from each jurisdiction. The SWA coordinates regional waste management matters.

Project Summary

The SWA is planning a local garden refuse processing facility and is currently seeking an appropriate site. The site identification process will include an extensive public involvement program.

Project Need

Effective recycling of garden refuse is the key to meeting the State's 50% waste recycling mandate (AB 939: Integrated Waste Management Act of 1989). Currently, the SWA member agencies generate about 200,000 tons of residential green waste annually. A local facility will ensure that the SWA member agencies have the long-term capability to properly recycle locally generated garden refuse in compliance with State requirements.

Currently, about half the waste is shipped out of the County for processing. This results in higher costs, significant air quality impacts and greater traffic problems than with a local facility.

The Sacramento GreenCycle facility is envisioned as a public-private partnership in which the facility is owned by SWA and operated by a private contractor. The SWA will make certain the facility is a good neighbor while providing the cost-effective garden refuse recycling service that the community needs.

The initial goal of the Sacramento GreenCycle facility is to manage about 100,000 tons of residential green waste annually.

Project Status

A list of potential facility sites is currently being identified. The project team hopes to present a short list of candidate sites to the SWA Board in December and to recommend a preferred greencycling facility location to the Board next spring.
